Notes:

- (a) The SASO Quality mark (SASO QM) solely issued by SASO is mandatory for all products falling under the scope of this Technical Regulation. Hence no intervention is required by Offices to certify these products. Intertek Offices are hereby informed to advise the Manufacturer/Client to apply directly to SASO for the SASO QM through SASO's JEEM website (<https://jeem1.saso.gov.sa/>).
- (b) Products covered under the scope of these technical regulations clearing KSA Ports/Borders after 01st April 2019 shall be accompanied by CoCs issued through SABER platform except for those Shipments having an ASTRA generated CoC issued before the implementation date of 15th March 2019.
- (c) KSA IGO has received further updates from SASO that P-CoCs and S-CoCs for all Electrical Low Voltage Products (also known as LVE/LVD appliances) shall be processed through the SABER platform only. Such Electrical Low Voltage products include the above notified G-Mark Electrical products (which require the mandatory Gulf Type Examination Certificate) as well as non-G-Mark products (which shall be certified based on applicable SASO and/or IEC Electrical Safety Standards taking into account the National deviations and other general essential requirements).
- (d) Products covered under the scope of these technical regulations clearing KSA Ports/Borders after 15th June 2019 shall be accompanied by CoCs issued through SABER platform except for those Shipments having an ASTRA generated CoC issued before the implementation date of 01st June 2019.
- (e) Products covered under the scope of these technical regulations clearing KSA Ports/Borders after 15th August 2019 shall be accompanied by CoCs issued through SABER platform except for those Shipments having an ASTRA generated CoC issued before the implementation date of 01st August 2019.
- (f) Intertek is not accredited by SASO in all the regions for certifying products covered under the scope of Technical Regulation for Front, Rear and Side Barriers for Trucks and Trailers and Technical Regulation for Trailers and Semi-Trailers. Intertek Offices therefore will not receive any requests for Certification of such products through the SABER Platform. If requests for Certification are received outside the SABER platform, then such Clients shall be redirected to apply through the SABER Platform and choose a Certification Body accredited by SASO to certify such products.
- (h) Products covered under the scope of these technical regulations clearing KSA Ports/Borders after 15th November 2019 shall be accompanied by CoCs issued through SABER platform except for those Shipments having an ASTRA generated CoC issued before the implementation date of 01st November 2019.
- (i) Products covered under the scope of these technical regulations clearing KSA Ports/Borders after 15th December 2019 shall be accompanied by CoCs issued through SABER platform except for those Shipments having an ASTRA generated CoC issued before the implementation date of 01st December 2019.
